






Standard Terms and Conditions of Sale

- 1. Terms: 2% 35 days, net 45 days.
- 2. Freight: FOB LASCO warehouses. Prepaid on orders for products only totaling 1\$1650 net for one shipment to single destination within the contiguous United States.
- 3. Minimum Order: \$100 net. Smaller orders billed at this minimum charge.
- 4. Claims for shipping errors must be made within 15 days to LASCO. Claims for damage or shortages should be directed promptly to the common carrier by the consignee.
- 5. Returns will be accepted only by prior authorization and if shipped freight prepaid. Returned merchandise subject to a 25% handling/restocking charge.
- 6. Pricing is subject to change without prior notice. However, prior notification will be given in the event of price changes in the period between order placement and scheduled shipment.
